## 1<sup>st</sup> SEACF Instructor Training Course

The first SEACF Instructor Training course was conducted in Klang, Malaysia. The course was based on the newly endorsed SEACF standards approved at the last meeting.

The course was conducted by Mr Amir Moostafa and Mr Aizan Asmaon from Singapore and attracted 16 participants from Malaysia, Thailand, Singapore, Brunei and Indonesia. Breakdown of expenses for the course are as follows:

## **SEA Games in Korat, Thailand**

The meeting was updated that the Secretariat have been corresponding with the Sports Authority of Thailand or SCAT to consider including Sport Climbing either as a medal or demo sport.

SCAT responded that they will table our request at the next SEA Games council meeting however advised that the sport first need to be included as a demo event before it can be considered as a medal sport.

In the meantime, continuous efforts will be made to lobby for the inclusion.

#### **2007 Activities**

The meeting agreed that in view of the rising cost for overseas travel, only one main and one youth event will be considered for future competitions. This will help to reduce the federation cost considering their needs to participate in other events like the Asian Indoor Games, Asian Championship, Asian Youth Championship and others.

However, the meeting agreed that where opportunity arise SEACF events can be conducted few days prior to other events hosted by SEA countries eg Asian Championship.

The following courses were also considered in 2007/08:

- a. Judges;
- b. Route setter; and
- c. Instructor Training.

More details will be forwarded to all members once it's available.

The meeting ended at 12pm. All members were brought to a site visit of the climbing wall in Brunei Nature Park.
